HOUSE OF REPRESENTATIVES

HB 1054 --- Sponsor: **Lant, Bill (131)** REIBOLDT (Co-sponsor)

Changes the laws regarding unlawful picketing or protesting of a funeral

Status: Pre-filed; 1/04/2012 - Read First Time (H); 1/05/2012 - Read Second Time (H)

HB 1084 --- Sponsor: **White, Bill (129)** DAVIS, KELLEY (126), CURTMAN AND BROWN (116) (Co-sponsors)

Adds veterans' charitable organizations to the zoning exception regarding the establishment of a retail business selling donated goods in an area where other businesses engage in retail sales

Status: Pre-filed; 1/04/2012 - Read First Time (H); 1/05/2012 - Read Second Time (H)

HB 1085 --- Sponsor: **White, Bill (129)** KELLEY (126), SCHAD, SOLON, BROWN (116) AND DAVIS (Co-sponsors)

Adds an additional \$1 to the excursion gambling boat entrance fee with the moneys to be deposited in the Veterans Commission Fund

Status: Pre-filed; 1/04/2012 - Read First Time (H); 1/05/2012 - Read Second Time (H)

HB 1093 --- Sponsor: **Elmer, Kevin (141)** FITZWATER, LANT, WHITE, REIBOLDT, CAUTHORN, JONES (117) AND GUERNSEY (Co-sponsors)

Allows for a special license plate for a person who has received the Navy Cross

Status: Pre-filed; 1/04/2012 - Read First Time (H); 1/05/2012 - Read Second Time (H); **Referred: Transportation (H)**

HB 1097 --- Sponsor: **Shumake, Lindell (6)** KELLEY (126), WRIGHT AND GATSCHENBERGER (Co-sponsors)

Allows a person to apply for a veteran designation on his or her driver's license or identification card upon providing specified proof of service

Status: Pre-filed; 1/04/2012 - Read First Time (H); 1/05/2012 - Read Second Time (H)

HB 1098 --- Sponsor: **Shumake, Lindell (6)** KELLEY (126), WRIGHT AND GATSCHENBERGER (Co-sponsor)

Expands the exemption for resale of donated goods for charitable purposes to include IRS Code Section 501(c)(19) organizations

Status: Pre-filed; 1/04/2012 - Read First Time (H); 1/05/2012 - Read Second Time (H)

HB 1099 --- **Sponsor:** **Fitzwater, Paul (152)** LASATER, ELMER, COOKSON AND CONWAY (27) (Co-sponsor)

Designates March 26 of each year as "Veterans of Operation Iraq/Enduring Freedom Day"

Status: Pre-filed; 1/04/2012 - Read First Time (H); 1/05/2012 - Read Second Time (H)

HB 1100 --- **Sponsor:** **Fitzwater, Paul (152)** CONWAY (27), LICHTENEGGER, LASATER, ELMER, COOKSON, SCHAD, ASBURY, FUHR, DAVIS, BRATTIN, DIEHL, CROSS, HAMPTON, CAUTHORN, MOLENDORP, SCHOELLER, REDMON, SMITH (150) AND WIELAND (Co-sponsors)

Designates March 30 of each year as "Vietnam Veterans Day"

Status: Pre-filed; 1/04/2012 - Read First Time (H); 1/05/2012 - Read Second Time (H)

HB 1105 --- **Sponsor:** **David, Day (148)**

Allows the Adjutant General to waive the maximum age requirement for the state militia

Status: Pre-filed; 1/04/2012 - Read First Time (H); 1/05/2012 - Read Second Time (H)

HB 1110 --- **Sponsor:** **Barnes, Jay (114)**

Authorizes the establishment of veterans treatment courts to dispose of cases which stem from substance abuse or mental illness of military veterans or current military personnel

Status: Pre-filed; 1/04/2012 - Read First Time (H); 1/05/2012 - Read Second Time (H)

HB 1120 --- **Sponsor:** **Wells, Don (147)** DUGGER, KELLEY (126), WRIGHT, ROWLAND, PHILLIPS AND SCHAD (Co-sponsors)

Requires the department of transportation to add language to Missouri Welcome signs expressing the state's gratification for the service of military personnel

Status: Pre-filed; 1/04/2012 - Read First Time (H); 1/05/2012 - Read Second Time (H)

HB 1128 --- **Sponsor:** **Largent, Scott (120)**

Authorizes the presentation of a Missouri National Guard Overseas Training Ribbon, a Missouri National Guard State Partnership Program Ribbon, and the Order of Minuteman Award

Status: Pre-filed; 1/04/2012 - Read First Time (H); 1/05/2012 - Read Second Time (H)

#HB 1160 --- Sponsor: [Solon, Sheila \(55\)](#) CAUTHORN, KORMAN, WALLINGFORD, LASATER, HIGDON, FISHER, HAEFNER, NICHOLS, LANT, LICHTENEGGER, DAVIS, WHITE, BERRY, LONG, SCHUPP, HOUGHTON, WYATT, RUZICKA, NOLTE, DENISON, ROWLAND AND HUBBARD (Co-sponsors)

Requires an excursion boat licensee to pay an additional admission fee equal to 50% of the required fee to be deposited into the Veterans Commission Capital Improvement Trust Fund

Status: 1/05/2012 - Introduced and Read First Time (H)

#HB 1161 --- Sponsor: [Solon, Sheila \(55\)](#) KELLY (24), FISHER, HAEFNER, HIGDON, NICHOLS, DAVIS, LANT, WHITE, BERRY, LONG, HOUGHTON, WYATT, RUZICKA, CAUTHORN, NOLTE AND ROWLAND (Co-sponsors)

Increases the annual amount of moneys to be transferred from the Gaming Commission Fund to the Veterans' Commission Capital Improvement Trust Fund

Status: 1/05/2012 - Introduced and Read First Time (H)

HCR 5 --- Sponsor: [Rowland, Lyle \(143\)](#) FRANZ, WALLINGFORD, SOLON, PHILLIPS, SHUMAKE AND SATER (Co-sponsors)

Strongly urges all employers in this state to give all veterans in their employ a day off for Veterans Day

Proposes a constitutional amendment requiring the State Lottery Commission to develop and sell a Veterans Lottery Ticket to support the Veterans Commission Capital Improvement Trust Fund

SB 466 --- Sponsor: [Munzinger, Brian \(18\)](#)

Modifies how money in the Gaming Commission Fund is allocated

Status: Pre-filed; 1/04/2012 - Read First Time (S); 1/5/2012 - Second Read and **Referred S Ways and Means and Fiscal Oversight Committee**

SB 498 --- Sponsor: [Munzinger, Brian \(18\)](#)

Prohibits cities from restricting veterans organizations from operating re-sale shops in certain areas

Status: Pre-filed; 1/04/2012 - Read First Time (S); 1/5/2012 - Second Read and **Referred S Jobs, Economic Development and Local Government Committee**

SB 499 --- Sponsor: [Munzinger, Brian \(18\)](#)

Imposes an additional admission fee for excursion gambling boat licensees to fund Veterans Commission capital improvements

Status: Pre-filed; 1/04/2012 - Read First Time (S); 1/5/2012 - Second Read and Referred S Ways and Means and Fiscal Oversight Committee

SB 564 --- Sponsor: **Brown, Dan (16)**

Waives the motorcycle roads skills test for members of the armed forces who have successfully completed certain military motorcycle rider training courses

Status: Pre-filed; 1/04/2012 - Read First Time (S); 1/5/2012 - Second Read and Referred S Transportation Committee; 1/11/2012 - Hearing Scheduled S Transportation Committee

SJR 28 --- Sponsor: **Munzinger, Brian (18)**

Amends the Constitution to require the development and sale of a veterans lottery ticket

Status: Pre-filed; 1/04/2012 - Read First Time (S); 1/5/2012 - Second Read and Referred S Ways and Means and Fiscal Oversight Committee
