Work hard from now until the Department Convention, we can make 100%

Give veterans a place to go, so they don't go to a dark place

Sr Vice Commander Jerome Goolsby: "Are there any questions?"

PDC George Scarborough asked, "What is our membership compared to today with last year? How many districts have performed revitalizations this year?"

Sr Vice Commander Jerome Goolsby responded:

Districts that have not done a revitalization should do so in short order, before the end of the year

Districts that have done revitalizations – 5 districts

Revitalizations have proven to be successful for increasing membership

Commander John Buckwalter – I believe we are pretty much at the same numbers as last year.

86% renewals; 85% goal in February. Need to concentrate on finding new members. Jerome said that we just missed the goal. Getting more and more challenging. Need 1000 new members by March 12.

If your post is below 75%, need to reach out and find out what the problem is. Districts need to reach out to their posts. Need to get back on track. If you haven't done a revitalization, do one.

Commander John Buckwalter - Report from Past Department Commanders Advisory Study Group

David Voyles stated that two individuals are looking into Service Officers;

Mark Clark is waiting for a return phone call, should be early next week

David Lee explained that the process needs to be understood; how money is allocated from Veterans Administration to our service officers

Received \$27,000 less this year than last year. We need more money, so we can support our service officers.
