

2	COMMANDER GRIGSBY: Please rise. The
3	colors of our country being in their proper place,
4	we will render a right-hand salute. One, two.
5	Uncover. Department Chaplain Marvin

1 MR. GOOLSBY: Goolsby, Historian. So 2 moved. 3 COMMANDER GRIGSBY: Goolsby. Do I 4 hear a second? 5 MR. SHAFER: Second by 16th District Commander Dave Shafer. 6 7 COMMANDER GRIGSBY: Thank you. Is 8 there any discussion? Seeing none. All in favor 9 of the minutes signify so by saying aye. 10 (Aye responses.) 11 COMMANDER GRIGSBY: Any opposed nay. 12 (No response.) COMMANDER GRIGSBY: Hearing no nays. 13 14 The motion has passed. 15 We will now have subcommittee report 16 by George Scarborough. George. 17 MR. SCARBOROUGH: I have negative 18 report. 19 COMMANDER GRIGSBY: No report. Do we 20 have any recommendations for new post charters? 21 ADJUTANT FINLEY-JACKSON: That will 2.2 be no, Commander. 23 COMMANDER GRIGSBY: There are none. 24 Do we have any recommendations for post mergers? 25 ADJUTANT FINLEY-JACKSON: No,

1 Commander. 2 COMMANDER GRIGSBY: There are none. 3 Thank you. Do we have any recommendations for post 4 charter cancellations? 5 ADJUTANT FINLEY-JACKSON: No. COMMANDER GRIGSBY: There are none. 6 7 New business. Please mark your calendars. We will 8 have a spring Department Executive Committee 9 meeting on February 19, 2022 at 1 p.m. at Post 152 in Ashland, Missouri, subject to change. 10 11 MR. BARNES: February the what? 12 COMMANDER GRIGSBY: February 19th. MR. GOODIN: At one o'clock you said? 13 14 COMMANDER GRIGSBY: At one o'clock at 15 Post 152, but that's subject to change. It's the 16 Washington, D.C. conference, so we may have to 17 change that. 18 Does anyone have anything else for 19 new business? 20 MR. GOODIN: Commander? 21 COMMANDER GRIGSBY: Yes. 2.2 MR. GOODIN: Tom Goodin, NEC. I have 23 two things. National is coming out with a program 24 to benefit children and youth suicide prevention 25 program. They are excising a 25 cent per capita

1	for each department. Missouri's bill will be
2	approximately \$8,000 a year for seven years. In
3	the commanders past commanders meeting, we came
4	up with the idea that we will have a second drawing
5	to go along with and we'll call it the blue
6	drawing. Tickets will be blue. And instead of
7	stepping on Lowry's toes and giving away the same
8	amount, it will be determined how we break that
9	money up, but roughly that should bring in 18 to
10	\$20,000 a year. And if it's successful, we'll keep
11	it going and that money will revert to the
12	Department.
13	So I guess I'm making a motion that
14	Missouri follow National's lead and commit to
15	paying the per capita tax for the next seven years.
16	COMMANDER GRIGSBY: Tom has made the
17	motion. Do I hear a second?
18	MR. SLOCUM: I'll second. Alex
19	Slocum, 6th District.
20	COMMANDER GRIGSBY: Alex Slocum
21	seconds. Is there any discussion?
22	MR. GOOLSBY: Goolsby, Historian.
23	Tom, I understand, then, that the Past Commanders
24	Club is going to do that drawing?
25	MR. GOODIN: No, the Past Commanders

1 Club will not do the drawing. The drawing will be held by the Department to coincide with Lowry's 2 3 original drawing to not to take away from her, and 4 it will be a blue ticket or whatever. 5 MR. GOOLSBY: And that money will 6 go --7 MR. GOODIN: That money will go to 8 cover that expense. 9 MR. GOOLSBY: Thank you. 10 COMMANDER GRIGSBY: Are there any 11 more questions up here? Yes, sir, Terry. 12 MR. LANNING: Terry Lanning, chairman 13 of the Finance Commission. We're now scheduled to 14 have two sweepstakes per year, right? So this will 15 be in addition to that. I just want to make sure 16 that we're not talking about using one of those. 17 MR. GOODIN: No. It will be a new 18 one. 19 COMMANDER GRIGSBY: Kerry. Kerry 20 Boardman. 21 MR. BOARDMAN: Kerry Boardman, Past 2.2 Department Commander, District 5. Two years ago I 23 was standing where you're standing, Commander, and 24 we made major cutbacks. Everybody sitting at this 25 DEC took a cutback. Where are we coming up with

1	this additional money to pay National? That's all
2	I'm asking. I hear that we're going to have this.
3	If we're going to do this, I say you wait till the
4	money comes in before we start sending money out,
5	or we can give everybody the money back they've got
6	coming. Thank you, Commander.
7	COMMANDER GRIGSBY: Any other
8	discussion? Yes, sir.
9	MR. VOYLES: Dave Voyles, Past
10	National Vice Commander. We have we have two
11	every year for filling in and trying to win the pot
12	or whatever we do with the tickets. My
13	understanding, they're wanting \$8,000 a year for
14	how many years?
15	MR. GOODIN: Seven.
16	MR. VOYLES: Seven. So \$56,000?
17	MR. GOODIN: Right.
18	MR. VOYLES: And you're talking about
19	adding another sweepstakes to take care of this.
20	MR. GOODIN: That's not written in
21	stone. We can't take \$8,000 out of the department
22	without trying to recoup that money. If someone
23	has a better idea to raise the funds, you know,
24	you-all were sitting in that commanders meeting
25	when this was discussed. Nobody said anything.

1	MR. VOYLES: What commanders meeting?
2	MR. GOODIN: I stand corrected. It
3	was a meeting with never mind.
4	MR. VOYLES: Yeah. Okay.
5	MR. GOODIN: It's a national program.
6	David, you've been a National Vice Commander.
7	You've been a Commander. You've been with
8	National. Are you saying you want Missouri to be
9	the only department that doesn't follow suit and
10	follow the national program? For me, I'm not for
11	that.
12	MR. VOYLES: Do I have the floor,
13	Commander?
14	COMMANDER GRIGSBY: You have the
15	floor.
16	MR. VOYLES: I'm not saying that.
17	Don't put words in my mouth, Thomas. What I'm
18	saying is we already have two every year. Okay?
19	My understanding, if I'm wrong, Lowry, we make
20	approximately 20,000 each one?
21	ADJUTANT FINLEY-JACKSON: Thereabout.
22	MR. BUCKWALTER: A little less than
23	that, David.
24	ADJUTANT FINLEY-JACKSON: It's a
25	little less this year.

1	MR. VOYLES: We make enough that if
2	we wanted to take out of these two we got now,
3	giving their \$8,000 until we reach their 56, which
4	in terms if you make 20, we give them 8, at least
5	12,000 goes back into the Department if we need
6	things. So we're getting some of that.
7	If you create another one, you know,
8	there's only so many lotteries they're going to get
9	involved in. You may not make much money. But I
10	think we ought to just utilize the two we got now.
11	Whatever we make out of that, take that \$8,000
12	until we get their 56,000 done, and at least the
13	other 12,000 will stay with this Department, be
14	able to help us in the area of our service
15	officers, be to able to help our veterans at this
16	department.
17	So that is my feeling. If that's the
18	way it's going to be handled, I don't have a
19	problem with that because we've got the money in
20	it, but we don't want to give the whole 57,000 at
21	once. We still want income coming in. I've been
22	fighting for the foundation for this department to
23	be able to put \$29,000 into this department, and I
24	haven't you know, and that's where this is going
25	to go is National Foundation. No. I want us to
1	

1	work it. But don't forget, we have a foundation
2	right here that we're trying to help ourselves. So
3	that's my statement.
4	MR. GOODIN: Commander. Tom Goodin,
5	NEC. The only reason we came up with a raffle is
6	we have three events a year. We have the spring
7	DEC conference, we have the fall conference, and we
8	have the convention. So it was our thoughts that,
9	with three events, we could have three raffles.
10	And if that third raffle only brings in \$10,000
11	instead of the other amount, so be it. We're
12	\$10,000 ahead or whatever that figure brings.
13	Whatever that raffle brings in, that's money we're
14	ahead.
15	So we're not trying to step on
16	anybody's toes, fight against any other raffle. We
17	just felt it was a quick way to raise money, that
18	people seem to respond, and we were going to break
19	it up into more winners, smaller amounts to the
20	winners and have more winners.
21	So if you come up with a better way
22	to raise money, I'm all for it. It's just a
23	suggestion. I'm like you, I'm not for just taking
24	\$8,000 a year for the next seven years and not
25	trying to replace it or earn it.

1	I'll amend my motion that we pay the
2	\$8,000 for the next seven years, or 8,056 or
3	whatever it is, a little over \$8,000, and we
4	determine later how we're going to raise the funds
5	to try to replace it from the other two drawings.
6	JUDGE ADVOCATE STROM: So we have an
7	amended motion and we need a second.
8	MR. GOOLSBY: Goolsby, Historian.
9	I'll second his amended.
10	COMMANDER GRIGSBY: Say that again.
11	JUDGE ADVOCATE STROM: Cassie Strom,
12	Judge Advocate. So we have an amended motion. We
13	have a second on the amended motion. Is there
14	discussion on it?
15	MR. BUCKWALTER: Yes. John
16	Buckwalter, Finance Officer. I was unaware of this
17	additional assessment. I believe that it probably
18	is in our best interests to participate, but when
19	would the first payment be due? Is it possible to
20	simply enter this into analysis by the Finance
21	Commission and be entered into the regular budget
22	process?
23	MR. GOODIN: To answer your
24	question Tom Goodin, NEC we found out about
25	it at NEC. I don't think the program's been

1	launched yet. I got to finance, Terry, with the
2	Ted from NEC that's running for national commander
3	and with Rich. They explained the program to me,
4	what it's going for, to help train service officers
5	to prevent suicide in children and youth.
6	So I thought I did the right thing in
7	getting Terry involved. The announcement will come
8	to Lowry when it starts, but I can guarantee the
9	first payment's going to be due this year before
10	this commander goes out of office.
11	And the following six commanders have
12	accepted this project as their project for the next
13	six years. So we won't get a second commander's
14	project dumped on us. This is a seven-year
15	process. All the following national commanders are
16	on board.
17	MR. BUCKWALTER: But national
18	commanders projects have always been funded by
19	voluntary donations from within the Department.
20	MR. GOODIN: But this is not that.
21	This is an assessment of 25 cents per capita, per
22	member.
23	MR. BUCKWALTER: Is it an assessment
24	or a suggested contribution?
25	MR. GOODIN: Well, I can't answer

1 that because they haven't -- I guess they can't demand you make it. I would say it would have to 2 3 be a suggested contribution, but they -- George, 4 you have that tally sheet. 5 ADJUTANT FINLEY-JACKSON: They may 6 have gave it to you. I'm saying they haven't sent 7 me anything. 8 MR. GOODIN: National hasn't launched 9 yet. We're just telling you this is coming aboard, and the first payment will probably be due before 10 11 we meet again. 12 MR. CHARLES GOODIN: Commander. 13 COMMANDER GRIGSBY: Yes. 14 MR. CHARLES GOODIN: Charles Goodin, 15 Past Department Commander. There's been 16 assessments on the department forever. I mean, we've not always paid them. They usually -- when 17 18 you go to national, they want a dollar a member a 19 year per capita for this, that or the other, and 20 we've never paid them to the point. 21 So I honestly don't think, other than 2.2 a dues increase, National can command you to pay 23 anything. That's the only way they can get any 24 more money. It is an assessment and it's a 25 request. I really -- doesn't matter. I mean, if

1	we don't pay 8,000 in every year, we can keep
2	paying till we get it paid. But this discussion
3	can go on in this meeting for a very long time. A
4	solid idea will have to be drafted and come up.
5	But again, it's not like taking a
6	loan on a house. You don't have to make payments
7	on it, and they're not going to repossess your
8	charter. So it's a request.
9	COMMANDER GRIGSBY: John.
10	MR. BUCKWALTER: My point is, if it's
11	clearly the intent of the Department Executive
12	Committee to fulfill this requested contribution,
13	then I think that information should be referred to
14	the Finance Commission and the commission come up
15	with a way to pay during our budget process and
16	then bring it back to the DEC in February.
17	MR. GOODIN: Tom Goodin, NEC.
18	Finance department does not run this Department.
19	This Department makes its own decisions.
20	MR. BUCKWALTER: No.
21	MR. GOODIN: Hang on. I've got the
22	floor. I did the right thing. I got Terry
23	involved. He was aware of it. He told me about
24	some set-aside money. He wasn't worried about
25	making the first payment. I tried to cross all the

1	Ts and dot all the Is. I realize this is a shock
2	to everybody. It's a program that I think we need
3	to fulfill. I think if we don't fulfill our
4	obligation, it's going to come back in years to
5	haunt us.
6	I've got a motion on the floor, so
7	I'm going to suggest we call the question. Like
8	Charlie said, we can debate it all we want. I've
9	got Terry involved. We've got the money. We're
10	trying to come up with a way to make more money.
11	So I've got a motion on the floor. Please call the
12	question.
13	JUDGE ADVOCATE STROM: Is there any
14	other discussion?
15	COMMANDER GRIGSBY: Is there any
16	other discussion? Yes.
17	MR. SAPP: Commander, Brian Sapp,
18	8th District. Before you call that question, could
19	you repeat the amended motion?
20	JUDGE ADVOCATE STROM: So the motion
21	is just Cassie Strom, Judge Advocate. The
22	motion and Tom, correct me if I'm wrong is
23	that we pay the 8,000 per year and that the exact
24	means and way that we make those payments will be
25	determined at a later time. Is that correct?

1 business to come before --2 SR. VICE COMMANDER NOONAN: Gary, I 3 had one thing. 4 MR. GOODIN: I'm not through with my new business. Are we done with this one? 5 6 COMMANDER GRIGSBY: We are done with 7 this one. 8 MR. GOODIN: Tom Goodin, NEC. 9 Commander, I wish you would appoint a commission 10 called the Past Department Commanders, and I would 11 like this commission to be chaired by David Voyles 12 and the second chair Rich Heigert, and that this 13 commission will meet at all three meetings, come up 14 with ideas and ways to help the Department, and 15 make suggestions to the Department when we see 16 something that might be able to be inputted. Ιt 17 can't be passed without the vote of the DEC. And 18 the only stipulation that we have, because we don't 19 want anybody thinking a current commander is 20 pushing an agenda, you have to be a past commander 21 to be a part of the commission. 2.2 So I'm asking -- you don't need a 23 I'm asking you to appoint that commission vote. with David Voyles as chairman and Rich Heigert as 24 25 co-chairman. You have the authority to appoint a

1 commission. 2 COMMANDER GRIGSBY: I will appoint 3 the commission with David Voyles as chair and vice 4 chair as Rich Heigert, and that will be Past 5 Department Commanders. 6 MR. GOODIN: A sitting commander 7 cannot attend. We don't want the commander there 8 trying to push his or her agenda. 9 COMMANDER GRIGSBY: All right. So I will appoint that commission. Under other business 10 11 to come before -- yes, David. 1.2 MR. SHAFER: That is an ad hoc 13 committee, is that correct, not a commission? 14 COMMANDER GRIGSBY: It actually is. 15 It's an ad hoc committee. 16 MR. SHAFER: Thank you. 17 COMMANDER GRIGSBY: You used the term commission, but it's actually an ad hoc committee 18 19 that's appointed by the commander. 20 So at this time, John Buckwalter --21 George Scarborough, Past Department Commander. 2.2 MR. SCARBOROUGH: Thank you. George 23 Scarborough, Alternate NEC, spokesperson for the 24 Past Department Commanders. We had a meeting on 25 Friday, October 15th, in Truman C. Several issues

1	were discussed in the Past Commanders meeting,
2	several items of importance. A couple of the items
3	we think were important enough to bring to this
4	body, to the DEC.
5	First and foremost is that the Past
6	Department Commanders recommend to the DEC that the
7	Department reinstate a formal means of
8	communication, whether that be digital and/or
9	printed, to our membership. It is requested that
10	the Media and Communications Committee be tasked
11	with determining the feasibility and method for
12	these formal communications.
13	Additionally, it is recommended that
14	monthly mailings be reinstated immediately to our
15	department posts. Subsequent to our meeting, we
16	believe the Media and Communications Committee has
17	met, and we look forward to their findings.
18	Respectfully submitted, Past
19	Department Commanders, Department of Missouri.
20	MR. GOODIN: Are you making that a
21	motion to reinstate the monthly mailing to the
22	posts?
23	MR. SCARBOROUGH: I make this a
24	motion from the Past Department Commanders.
25	MR. GOODIN: For what specific thing?

1	For just the monthly mailing, correct?
2	MR. SCARBOROUGH: No. For what I
3	just stated. I withdraw the motion. We'll wait
4	till we have reports from Media and Communications
5	as well as Terry Lanning, Finance Officer.
6	MR. GOODIN: Tom Goodin, NEC. What
7	about the issue of the monthly mailing that you
8	wanted to start immediately?
9	MR. SCARBOROUGH: If it doesn't
10	become addressed in the Media and Communications
11	presentation, then we'll make it a motion from the
12	floor. It will be today.
13	COMMANDER GRIGSBY: Now we will have
14	the Finance Commission chairman Terry Lanning's
15	report. Yes.
16	MR. CHESTER: Charles Chester,
17	District 4. I'm kind of new to this. What is the
18	difference between the new Past Commanders group
19	that was just designated and the Past Commanders
20	group that you just spoke for?
21	ADJUTANT FINLEY-JACKSON: They just
22	made it official, that's it.
23	MR. SCARBOROUGH: George Scarborough,
24	Alternate NEC. The Past Department Commanders used
25	to meet voluntarily as a group to come up with

1	ideas suggestions what have now and present them
1	ideas, suggestions, what have you, and present them
2	to this body. In this way, in asking for the
3	committee to be formed, we become a legal entity.
4	Rather than just a voice, we become a legal entity
5	that can report to this body, to this DEC,
6	regularly.
7	MR. CHESTER: Thank you.
8	MR. LANNING: Terry Lanning, chairman
9	of the Finance Commission. The Finance Commission
10	recommends the following changes: To transfer
11	\$100,000 to the investment account out of our
12	checking account. That's No. 1.
13	No. 2, to increase the Legionnaire
14	newspaper budget by \$21,000 so we can issue two
15	newspapers per year, newspapers mailed out.
16	And three, provide a new server in
17	headquarters for \$4,000. Ours is giving us a lot
18	of problems and we need to replace it. We've had
19	it for many years. That's my recommendations. So
20	we need a motion.
21	MR. SAPP: Brian Sapp, District 8. I
22	move that we institute the Finance Commission's
23	recommendations.
24	COMMANDER GRIGSBY: We have a motion.
25	Do I have a second?

1 MR. GOOLSBY: Goolsby, Historian. 2 I'll second. 3 COMMANDER GRIGSBY: We have a motion 4 and a second. Is there any discussion on the 5 motion? Seeing none. All those in favor of the 6 motion indicate so by saying aye. 7 (Aye responses.) 8 COMMANDER GRIGSBY: Any opposed nay. 9 (No response.) 10 COMMANDER GRIGSBY: Hearing no nays. 11 The ayes have it. Motion passed. 1.2 Now, then, Media and Communication, 13 John Buckwalter, John. 14 MR. BUCKWALTER: The Media and 15 Communications Commission has been discussing the 16 issue of the publication of the Missouri 17 Legionnaire for our past two meetings. At the 18 National Media and Communication Commission 19 meetings and reviewing the results, we came to the 20 conclusion that the audience that makes up the 21 American Legion is not going to continue to read 22 newspapers online. They need the data in hand. 23 So we have discussed with the Finance 24 Commission and taken the advice of the Past 25 Department Commanders and are recommending that we

1 publish two paper editions in this fiscal year and 2 then plan as we enter the budgetary process for the 3 coming year to return to printed media for the 4 newspaper. And the schedule would be, on 5 6 December 15th we would publish a printed edition 7 that would include the holiday greetings, year-end 8 summary, details and plans for the spring DEC 9 meeting, oratorical contest and so on. That would have a deadline for articles by November 30th, and 10 11 again print media. 12 We would do a second edition on 13 March 1st, with a deadline for articles for 14 February 15th, and that would be a digital edition. 15 We would do a third edition and the final edition 16 for this fiscal year with a publication target of 17 June 3rd. That would include all the required convention information, the budgetary information 18 19 and so on. That would have a deadline for articles 20 of May 15th, and that would be a print edition. 21 Going into the next fiscal year, we 2.2 would anticipate an edition on September 15th 23 addressing planning for the fall conference and the 24 results of the national convention. That would have an article submission deadline of 25

1	September 1st or immediately after the national
2	convention. That would be a print edition.
3	So we anticipate the cost of a
4	printed edition for the current membership of the
5	Department at \$12,000. So that is what Terry will
6	address in a moment in terms of the Finance
7	Commission recommendation.
8	So that is the initial plan, and then
9	for the next fiscal year we will look at
10	publications on or around December, March, June and
11	September in '22 and '23. Brian.
12	MR. SAPP: Brian Sapp, 8th District.
13	Is there any extra cost involved to also make those
14	an electronic edition on the website?
15	MR. BUCKWALTER: No. Anything that
16	is published in print will also be available on the
17	website, which has been the case the past two
18	fiscal years.
19	One thing I would address is the
20	Media and Communications Commission is going to
21	send letters to those who normally contribute with
22	suggestions that we got from our friends at the
23	national headquarters of the American Legion Media
24	and Communications Association on how to write
25	articles and suggested timelines with reminders.

1	I would remind everyone that the
2	Adjutant is the editor of the Missouri Legionnaire.
3	She is not the author. Those seated around this
4	table and those representing their posts as post
5	information officers are the authors, and the
6	quality of the Missouri Legionnaire is a direct
7	result of the quality of what you send to include
8	in that paper. So that's important.
9	The other thing we talked about was
10	the post monthly mailing, which is actually an
11	electronic submission. We talked with the
12	Adjutant, and that will resume on a more scheduled
13	basis. She has always been sending the information
14	to the posts as it came in, but the posts have not
15	been looking at that as a monthly mailing. And so
16	we'll make sure that they know this is the monthly
17	mailing.
18	But that information has been going
19	down to the posts, but they may not be recognizing
20	it as a monthly mailing. So we'll work with the
21	department staff and so there'll be a scheduled
22	thing. It may have less information sometimes.
23	Sometimes it may have a great deal of information.
24	But that program never went away. It just lost its
25	title. I'm through with my report. I'll turn it

1 over --2 MR. GOODIN: I've got a question. 3 Goodin, NEC. Now, is it still just going to be two 4 published and two digital, is that --5 MR. BUCKWALTER: With budget 6 constraints this year, there will be two printed 7 editions in this fiscal year and one digital. Next 8 year we will have to see what the budget permits, 9 but the recommendation will be that we go all 10 printed. 11 MR. GOODIN: For four? 12 MR. BUCKWALTER: Yes. 13 MR. GOODIN: So roughly it's a 14 three-month period. 15 I say again --MR. BUCKWALTER: 16 MR. GOODIN: Hang on. 17 MR. BUCKWALTER: -- the schedule will 18 be --19 MR. GOODIN: I'm not done with my 20 question. In that event that we do that, then 21 we're going to have to make sure it contains all 2.2 the information of everything that's going to 23 happen in those following months and weeks so that 24 the Legionnaires know. We can't just do things 25 that already happened.

1	MR. BUCKWALTER: That's correct. The
2	Legionnaire needs to include future information.
3	And our masthead says we publish four times a year.
4	That was the original intent of the Missouri
5	Legionnaire was four publications a year.
6	MR. GOODIN: So we're going back to
7	\$48,000 a year?
8	JUDGE ADVOCATE STROM: We just have
9	one year approved.
10	MR. BUCKWALTER: We will see.
11	JUDGE ADVOCATE STROM: (Inaudible)
12	THE REPORTER: I'm sorry. I can't
13	hear the Judge Advocate.
14	MR. BUCKWALTER: No one is yet.
15	That's coming before you in a moment. So that's
16	the proposal. Again, this year the recommendation
17	is two printed editions. That should be within our
18	budgetary possibility. And then as we enter the
19	next budget cycle, we will have this year's
20	experience and we will then decide if we can go
21	forward to do four print editions in the following
22	year. I think it is a membership issue. Yes,
23	ma'am.
24	MS. BATLINER: Michelle Batliner,
25	5th District. Is there a limit on the number of

1	pages that you publish?
2	MR. GOOLSBY: We publish 12 pages.
3	That's what the system is set up for at this time.
4	One thing that the Media and Communications
5	Commission has agreed to do is to look into the
6	legal requirements on advertising in the paper,
7	whether we can make the paper pay for itself.
8	That's something that we haven't done
9	yet and will have to be done before we enter the
10	next budget cycle. But one goal would be to allow
11	advertising in the paper which would make it pay
12	for itself, but we need someone to assist us in
13	selling advertising, and it may change the format
14	of the paper from the established 12 page edition.
15	Sir?
16	MR. SCARBOROUGH: George Scarborough,
17	Alternate NEC. Will the monthly mailing still be
18	available online?
19	MR. BUCKWALTER: They will. That
20	will be the primary mode. They will be e-mails to
21	the posts, and then they'll be available online so
22	others can see them.
23	MR. SCARBOROUGH: Thank you.
24	MR. GOODIN: Tom Goodin, NEC. I
25	don't believe that the recommendation by the Past

1	Department Commanders was e-mailed to the posts.
2	It was to be a hard copy mailed through the mail.
3	Am I wrong?
4	MR. CHARLES GOODIN: Charles Goodin,
5	Past Department Commander. It was as Tom stated,
6	but I believe what you've designed in further
7	meeting with Media and Communication is a good
8	start on a monthly mailing. Very good.
9	MR. BUCKWALTER: The monthly mailing
10	has been by e-mail for almost two years. There is
11	a supplemental list that the staff uses for those
12	few posts that do not have an e-mail address, but
13	the vast majority of them are sent by e-mail
14	because the cost of postage to send out 200 packets
15	every month was overwhelming, much more than the
16	cost of the paper.
17	Dennis.
18	MR. WOELTJE: Dennis Woeltje, Past
19	Department Commander. The monthly mailings are
20	digital. However, they've not been submitted since
21	March. There's been no monthly mailing since March
22	digitally.
23	MR. BUCKWALTER: Staff will update
24	that, but the problem has been, information has
25	been sent. It just hasn't been called a monthly

1	mailing. The information has gone to the posts.
2	But department staff will look at that and, again,
3	something will say monthly mailing and it will go
4	out by the e-mail so that and it will be on the
5	website and online.
6	So that packaging issue will be
7	addressed. It's not a question of the posts not
8	getting the information. It's just a packaging
9	issue and marketing and basically something that
10	says this is the monthly mailing. So it will be
11	available in the future as a package that you can
12	identify and say this is the July monthly mailing.
13	David.
14	MR. VOYLES: Dave Voyles, Past
15	National Vice Commander. You've already passed the
16	money for the paper to get done. Wasn't that with
17	Terry? Yes, you have.
18	MR. BUCKWALTER: I'm sorry. I stand
19	corrected. It was in Terry's motion.
20	MR. VOYLES: Your recommendation is
21	showing how we're going to handle it, and all I'm
22	saying is your recommendation should be voted on
23	yes or no because you've got the money already, you
24	know how you're going to handle it, you've already
25	explained it to the DEC. Then we can call it

1 quits. 2 MR. BUCKWALTER: I'm happy with that, 3 sir. I didn't realize Terry included it in his 4 motion. I yield. COMMANDER GRIGSBY: So do I hear a 5 motion to --6 7 MR. GOOLSBY: Goolsby, Historian. Ι 8 move his recommendation be adopted. 9 MR. SCARBOROUGH: George Scarborough, Alternate NEC. Second. 10 11 COMMANDER GRIGSBY: We have a motion 12 and a second that the recommendations be adopted. 13 Any discussion? Seeing none. 1	anowing according to the mean the 15th
1	everyone, especially over the past year the 15th
2	and 17th Districts. We appreciate you-all having
3	us down there for our American Legion Legacy Ride
4	this year. We had about 440 miles over three days.
5	We had an absolutely great time. It rained on us
6	all three days, but it does that it seems like
7	every year, so we're pretty used to that.
8	This year total we sent to National
9	\$82,600. So that was a very good follow-up from
10	last year. Thank you. And that was not me and
11	that was not the Department ALR staff. That was
12	the posts, the chapters, the auxiliaries, the Sons
13	of the Legion out there doing fundraisers for us to
14	get us that money to send up. All we are, our ride
15	is a collection ride. Yes, we make a little bit of
16	money on that ride and have a good time doing that,
17	but the money is made throughout the year. So I
18	applaud all of you all.
19	I ask you to go back and have your
20	home posts and your Legion family continue those.
21	There's a lot of other great fundraising
22	opportunities out there and great organizations
23	that we can donate to, and I'll get into that at
24	the DEC in the spring, but for now we appreciate
25	all of those all of those donations coming in.

1	We have a great start this year
2	already. We have 38 chapters spread across the
3	state. Our membership is down from the last couple
4	of years. I attribute that to COVID. I think a
5	lot of our chapters had a hard time getting people
6	into the posts and into their meetings to get their
7	dues paid over the last year or two. So when the
8	shutdowns started last spring, that really put a
9	damper on last year's membership.
10	That has carried over to this year.
11	So our membership is down about half as far as per
12	capita what we had in previous years. We were up
13	to almost 1,100. Now we're down to 650 as far as
14	members across the state. We're going to work on
15	getting that back up. We've got a lot of ideas out
16	there.
17	I do want to take a moment to
18	introduce our new state ride captain David Bentley,
19	and if it pleases the Commander, I'd like to pass
20	the mic over to him so he can give us an idea of
21	what's coming up for next year's Legacy Ride.
22	MR. BENTLEY: Thank you, Brian. As
23	stated, I am David Bentley. I'm the ride captain,
24	also the chapter director for 152.
25	To continue on with the Legacy Ride,

1	this will be our eighth year, and each year we try
2	to make improvements based on the past experiences,
3	and we're hoping to do this this year.
4	One thing that's going to be
5	different this year than ever before is we are
6	doing a joint ride and we are riding with Kansas.
7	So the first day will be a sole Missouri ride. The
8	second day will be a Missouri and Kansas ride. So
9	we will ride halfway into Kansas, come back, ride
10	into Missouri, end the day on the second day as the
11	joint ride, and then we will separate and go our
12	own way for the third day. They are excited. We
13	are excited for that event.
14	My duties as the ride captain for the
15	Legacy Run are three primary goals. One, first and
16	foremost is to have a safe ride. The riders
17	themselves, we all ride safe. There is factors
18	that we have to contend with on the ride, but
19	overall that is the primary goal is to have a safe
20	ride.
21	The second goal, as stated, is to
22	raise money for the Legacy Fund. We do that
23	throughout the year, but our main focus again will
24	be the actual Legacy Ride. And third, and not to
25	forget, is for each and every rider to have fun.

1 That's what we're out there to do. 2 This year we're looking at riding 600 3 miles or more. So it should be a very good 4 turnout. So far the preliminary route is done. 5 The T-shirt design is complete. The poker chips 6 which were used to raise funds is done, and the patch for this year's ride is done. So we're way 7 8 ahead of the ball game where we need to be. 9 An interesting point is at the 10 Military Appreciation Day held at the fairgrounds, 11 the Governor came up to Brian and I afterwards and 12 wanted to thank us for our participation, and he 13 looked at us and said, You know, I always wanted to 14 ride one of those. Well, this year we sent a 15 letter to the Governor requesting his participation 16 in the ride, and we hope that we can fulfill his 17 request. 18 One last thing along COVID is it's 19 really stopped the Honor Flights. We're hoping 20 that this year that will cease, the Honor Flights 21 will resume, and the riders can get out and do the 22 Honor Flight escorts. Thank you. 23 COMMANDER GRIGSBY: Thank you, 24 Mr. Director and Mr. Ride Captain. We appreciate 25 the report, and we look forward to seeing the ride

1 this year. 2 Is there anything to come before the 3 DEC for the good of the order? David. 4 MR. SHAFER: Dave Shafer, 16th 5 District Commander, Oratorical Commission chairman. 6 Just like to remind everybody that on the 19th of 7 February, you've already got it on your calendar, 8 the spring meeting. On the 20th of February is the 9 state oratorical contest. 10 MR. SAPP: No. Sorry. It's the 11 27th. The oratorical has not changed. The only 12 date that changed was for the DEC. Sorry. Brian 13 Sapp, 8th District. 14 MR. SHAFER: Well, we'd like to 15 invite everybody to come to the oratorical contest. 16 COMMANDER GRIGSBY: I'll have a 17 reminder on further down in my script. Anything 18 else for the good of the order? 19 MR. GOOLSBY: Goolsby, Historian. 20 I'd like to make a motion that mileage be paid upon 21 submission of properly signed paperwork to the 22 Department Adjutant. 23 COMMANDER GRIGSBY: There's a motion. 24 Do I hear a second? 25 MR. REED: Mark Reed, 17th District.

1 Second. 2 COMMANDER GRIGSBY: There's a second. 3 Any discussion? Seeing none. All in favor signify 4 so by saying aye. 5 (Aye responses.) 6 COMMANDER GRIGSBY: Any opposed nay. 7 MR. GOODIN: No. 8 COMMANDER GRIGSBY: Motion passed. 9 MR. SCARBOROUGH: Question. 10 COMMANDER GRIGSBY: Yes. 11 MR. SCARBOROUGH: George Scarborough, 12 Alternate NEC. Are we going to have a membership 13 report? I've got a couple of questions on things 14 about the membership information you passed out. 15 COMMANDER GRIGSBY: Okay. Are you 16 prepared? Okay. 9	guess is what I'm asking?
10	SR. VICE COMMANDER NOONAN: I am
11	already working with every zone commander in here.
12	Most of the district commanders I have been in
13	contact one way or another for membership meetings,
14	revitalizations.
15	You know, we're still early on. So I
16	would appreciate if you'd give me the opportunity
17	to get some things on the schedule because it's
18	going to happen. I have very good zone commanders
19	that are going to work with me, that are willing to
20	work with me. So that's all I ask. Okay? There's
21	been errors in the computer system, and I'm not
22	saying it's all the computer. I may have made
23	typos myself. I'm not saying I'm perfect. But
24	it's going to happen.
25	MR. GOODIN: Again, we've all been in

1	your shoes, and our experience has been, we're at
2	the middle of October now, and then you go into
3	three months of winter, and all of a sudden
4	spring's here and you've got very little time to
5	hit your numbers. And if the Department of
6	Missouri doesn't hit all those numbers at the time
7	they're supposed to be hit, you can't make it up.
8	You're out. Even though if you wind up
9	100 percent later, if you don't hit the targets, it
10	doesn't
11	SR. VICE COMMANDER NOONAN: Okay. I
12	understand that. All right. I'm working on it.
13	Give me a little bit of leeway. Okay? Can we do
14	that?
15	MR. SCARBOROUGH: George Scarborough,
16	Alternate NEC. We can, Senior Vice, but I'll
17	second what Tom is saying. Early on is early on.
18	Dues come in quickly. But if you don't start
19	working the programs now before dues are delinquent
20	at the end of December, if you don't have some
21	revitalizations and some buddy checks going on that
22	we can report back to or work with these district
23	commanders on and by the way, Past Department
24	Commanders are ready to come to your districts or
25	your posts and help you out, give you advice and

1 help you do things with membership. That's a 2 commercial. But those things, we don't have a lot of time. 3 4 SR. VICE COMMANDER NOONAN: I got it. 5 Any other questions? Any other responses? 6 COMMANDER GRIGSBY: Thank you, Rose. 7 Cassie Strom, our Judge Advocate, has an 8 announcement. 9 JUDGE ADVOCATE STROM: Thank you. 10 Cassie Strom, Judge Advocate. 11 I have to just make a record on this. 12 We're going to be presenting or I guess the posts 13 will be presenting a cancellation through the DEC 14 which will probably happen by e-mail later this 15 In line with that, I have told Post 439 so fall. 16 the last member will transfer out that we will --17 once a properly executed deed to transfer property 18 that the post sits on, which is in a floodplain, 19 has been flooded out twice, is presented to the 20 Department Adjutant, that that document will be 21 signed off on and a veterans memorial park will be 22 created by the city of Valley Park. 23 I'm just doing that to make a record 24 of it so we can go back to the individual and let 25 them know that the DEC has been informed of this

1	and is aware of it and will hopefully follow the
2	actions once they come up. Thank you.
3	COMMANDER GRIGSBY. National's dress
4	code was sent out to you. Some of you how many
5	of you have gotten it? Okay. Read your e-mails
6	and communication that comes from Department, but
7	the red shirt, and then if you're on the dais or on
8	the stage, that's the coat and tie, although we
9	have prerogative to make the adjustment as we did
10	in the summer.
11	So we have the reminder on the
12	oratorical contest. It will be held 1 p.m. on
13	Sunday, February 27th, and that's in 2022, at
14	Southern Boone High School in Ashland.
15	Is there anything else for the good
16	of the order? Any further business? No further
17	business. Please rise, uncover. Our benediction
18	will be given by Department Chaplain Marvin Harper.
19	CHAPLAIN HARPER: Dismiss us with thy
20	blessing, oh God, as we leave this place with the
21	faith that thy spirit goes with us. Keep us
22	sensitive to our prompting to the end that all we
23	do will be according to thy will. Amen.
24	COMMANDER GRIGSBY: Cover. With the
25	colors of our country being in their proper place,

1	we will render the right-hand absolute. Ready.
2	One, two. I now declare this meeting of the
3	Department of Missouri American Legion Executive
4	Committee duly adjourned.
